Meeting was called to order at 5:00 P.M.

Commissioners present: Steve Bamsey, Tom Buco and Mike DiGregorio. Staff present: Superintendent Bruno Vallieres, Chief Solomon, and Bookkeeper Amy Snow. Joining from the town, Paul D and Andrew Smith.

Mr. Bamsey began with a discussion regarding the Memorandum of Understanding between CVFD and the Town of Conway. All present have looked over the memorandum and all agreed it appears that it looks pretty, simple. Paul D. said that hypothetically, if the town does absorb CVFD, probably the next thing to do would be to have a charter commission and see if it's time to go to a council form of government. In this way business can just keep going. Discussion ensued regarding budgets and fire coverage.

Bruno added that they had put in a new fire hydrant at the Fire Station and that they have lowered an area of the park parking lot to improve drainage.

Amy stated that every two years we have to have an Actuarial Valuation for GATSBY75. Mr. Digregorio made the motion to engage with Jefferson Solutions to do the Actuarial Valuation for 2022 and 2023. Seconded by Mr. Buco. Motion passed 3-0-0.

Amy then presented the draft for the 2023 Commissioners budget. Conversation ensued.
