The Chief stated that they made it through the month of May! That's now our busiest May on record. We did 130 calls, so we're currently 50 calls up from this time last year. We had a lot of high acuity calls in May, so we spent a lot of money too. Otherwise, things are going pretty good.

Mr. Bamsey asked about the road at Avesta Housing. The Chief stated that he told them straight up, I'm not going to sign the building permit for the next building (until plans are complete). Discussion ensued.

The Chief said that they're doing calls, everything else is still a struggle; you're trying to buy stuff and you can't.

Mr. Digregorio asked how the new ambulance was doing. The Chief stated that he's not a fan of the design. Discussion ensued.

The Chief stated that next week he has a whole series of meetings to go to and he is on vacation the week after that.
